An email address MUST be provided for distribution of RFP's and correspondence, see box #4 on form 254.

Consultants requested to prepare proposals will be selected by the WWDC, as per W.S. 9-2-1031, using information contained in the SOQ of the prime consultant and any sub-consultants, and the SOI of the prime consultant. **Firms offering professional engineering services must provide their Board issued Wyoming license number.**

The WWDC will be seeking authorization for these projects from the 2019 Legislature. If authorization is not granted, the selection-contract process will be discontinued.
